

GILL CLARKE BURSARY AWARDS 2024

This year Independent Dance is offering bursary awards to support practitioners to undertake <u>MA/MFA Creative Practice: Dance Professional</u>, a course led by Trinity Laban Conservatoire of Music and Dance in partnership with Independent Dance and Siobhan Davies Studios.

The bursary is named in honour of Gill Clarke (1954-2011), a renowned independent dance artist and educator and former Co-Director of Independent Dance. Gill Clarke was key to the development of MA Creative Practice: Dance Professional and the rigorous, curious and playful ethos at the heart of her approach to learning continues to underpin all of Independent Dance's work today.

This year the Gill Clarke Bursary Award scheme is funded and managed by Independent Dance as part of our 40th birthday celebrations. £10,000 in total is now available through individual awards ranging from £1,000 - £2500. Please read below for detailed criteria and how to apply. Please also note that unless Independent Dance secures further funding, this scholarship will only be available in 2024.

We know that underprivilege and under-representation in the arts works in a layered, intersecting way across race, gender, socio-economic class, neurodiversity, and dis/ability. These bursaries are intended to help reduce financial barriers to postgraduate study, and to support practitioners to undertake MA/MFA Creative Practice: Dance Professional who would not otherwise be able to do so.

WHO CAN APPLY FOR A GILL CLARKE BURSARY?

This bursary is open to practitioners based anywhere in the world.

To be eligible, applicants

- will have accepted the offer of a place on MA/MFA Creative Practice: Dance
 Professional full-time or part-time. (For information about the course and how to apply please see here)
- would not otherwise be able to afford to undertake postgraduate study
- can demonstrate what positive impact/s the course might have on their and/or other people's artistic development

HOW TO APPLY

Please send the following to <u>info@independentdance.co.uk</u> with 'Gill Clarke Bursary' as the subject heading, by **1 May 2024:**

A written statement of 500 words maximum explaining your eligibility for the bursary.

This should include:

- Confirmation that you have accepted the offer of a place on MA/MFA Creative Practice:
 Dance Professional, part-time or full-time or that you are already undertaking the programme part-time and enter the second year in September 2024
- Your reasons for applying for the bursary
- What the bursary would enable you to do which would not otherwise be financially possible, and how you envisage spending the bursary
- How you are planning to fund your studies and living costs
- Whether or not you are applying for other funding to support your studies and/or living costs
- An indication of whether you identify as being either from an under-represented background in the creative and cultural sector and/or, if you have lived experience of marginalisation due to race, gender, disability, long term health issues, neurodivergence, and/or socio-economic status.*
- Whether or not you have dependents, and/or have current or past caring responsibilities
- If as a child you were officially cared for by the state at any point

MANAGEMENT OF THE BURSARY AWARD

Successful applicants can choose to have the scholarship award paid directly to Trinity Laban to support course fees or receive it themselves after starting the course.

All scholarship holders will be requested to provide a brief written evaluation to Independent Dance at the end of their course of study

ABOUT GILL CLARKE

Gill Clarke (1954 – 2011) was an independent dance artist and co-director of Independent Dance from 1996-2011. She was a founding member of Siobhan Davies Dance Company and also performed and collaborated with other choreographers including Rosemary Butcher, Rosemary Lee, Janet Smith, Kate Brown and Marina Collard. Gill regarded teaching as an integral part of her artistic practice. She regularly led masterclasses and workshops internationally for students, professionals and companies, and collaborated with filmmaker Becky Edmunds on a multi-screen installation – *Stones and Bones*. Head of Performance Studies at LABAN from 2000-2006, she founded MA Creative Practice: Dance Professional which ID continues to lead in partnership with Trinity Laban and Siobhan Davies Studios. Gill was an Honorary Visiting Professor at University of Ulster, a joint NESTA fellow and a Trustee of Dance UK. She received a London Dance and Performance Award, the Jane Attenborough Award from One Dance UK and an MBE, which she returned in protest of the UK government's foreign policy in Iraq.

ABOUT INDEPENDENT DANCE

Independent Dance (ID) is one of the UK's leading dance organisations with a focus on artist and artform development.

Resident at Siobhan Davies Studios in London, ID supports the development of dance through radical enquiry, learning, community-building and audience engagement. ID has been artist-led since 1984 and is staffed by a team of five part-timers, all of whomsustain freelance practices alongside their role with the organisation.

Our public programme supports a wide range of interdisciplinary approaches to dance, somatic practices, improvisation and choreography. We collaborate with 100+ artists a year and with organisations across the UK/internationally to facilitate critically-engaged activity for artists, participants and audiences. Our year-round programme currently includes classes, talks, workshops, research projects and festivals as well asan online digital library of archival material.

Our aim is to generate a diverse and dynamic 'community of practice' which is not limited to one place or location and to agitate for positive change and justice within ID, the arts and society. Over the past five years, we have diversified our programme offerand expanded our reach, supporting a wide range of artists and practices through a live and online programme. We have undergone significant organisational change and revised our policies, including making commitments to anti-racist and anti-ableistworking practices and to reducing barriers to engaging with our programme and organisation at all levels. This ongoing work is critical to our future development.

Partnership is key to ID's work; over the past two years we have delivered projects with organisations including Sadler's Wells, Dance North, Candoco Dance Company and Center for Performance Research, with initiatives such as Fest en Fest and Contemporary Dance& Whiteness, and with Higher Education institutions including Roehampton University, C-DaRE Coventry University and Women's Art Library, Goldsmiths. ID forms a bridge between

professional and academic spheres, leading on the delivery of MA/MFA Creative Practice: Dance Professional with Trinity Laban and Siobhan Davies Studios.

Independent Dance and Siobhan Davies Studios (SDS) are partners in a National Portfolio Organisation consortium currently receiving regular funding from Arts Council England, with SDS as the lead partner. ID receives core funding of £71,000 ayear from ACE and generates further funding through project grant applications. ID's turnover is between 150k – 250k annually, and our programme operates largely on anincome-generating basis.

As such, ID is a thinktank, a hub for research, a meeting and learning ground, and a base for artists across generations. It is considered a 'home' organisation and reference point by a wide community across the UK and internationally.
